1. Government of Nepal (GoN) has allocated fund toward the cost of Monitoring and indentifying comparative Benchmarking of fixed broadand internet in major cities of Lumbani, Jarnali and Sudurpakshim Pardesh (Package 3) and intend to apply portion of this fund to eligible payments under the Contract for which this Expression of Interest is invited for National consulting service
2. The Nepal Telecommunications Authority now invites Expression of Interest (EOI) from eligible consulting firms (“consultant”) to provide the following consulting services: Assess, measure and analyze the QoS of fixed broadband internet service provided by the different operators in different locations of Nepal and conduct consumer survey and analyze the customers perception on quality of services of fixed broadband internet service in different locations of Nepal.
3. Interested eligible consultants may obtain further information and EOI document free of cost at the address Nepal Telecommunications Authority,Only EGp during office hours on or before 21-12-2022 12:00 or visit e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) or visit the client’s website <https://nta.gov.np/en/>
4. Consultants may associate with other consultants to enhance their qualifications.
5. Expressions of interest shall be delivered online through e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) only on or before 21-12-2022 12:00
6. In case the last date of obtaining and submission of the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
7. EOI will be assessed based on Qualification 50.0 %, Experience 40.0 %, and Capacity 10.0 % of consulting firm and key personnel. Based on evaluation of EOI, only shortlisted firms will be invited to submit technical and financial proposal through a request for proposal.
8. Minimum score to pass the EOI is 60

## **B. Instructions for Submission of Expression of**

# Instructions for Submission of Expression of Interest

1. Expression of Interest may be submitted by a sole firm or a joint venture of consulting firms.
2. Interested consultants must provide information indicating that they are qualified to perform the services (descriptions, organization and employee and of the firm or company, description of assignments of similar nature completed in the last 7 years and their location, experience in similar conditions, general qualifications and the key personnel to be involved in the proposed assignment).
3. This expression of interest is open to all eligible consulting firm/person/ company/ organization.
4. In case, the applicant is individual consultant, details of similar assignment experience, their location in the previous 4 years and audited balance sheet and bio data shall be considered for evaluation.
5. The assignment has been scheduled for a period of [Insert time, period in years and/or months]. Expected date of commencement of the assignment is 01-03-2023.
6. A Consultant will be selected in accordance with the QCBS method.
7. Expression of Interest should contain following information:

8. Applicants may submit additional information with their application but shortlisting will be based on the evaluation of information requested and included in the formats provided in the EOI document.

The Expression of Interest (EOI) document must be duly completed and submitted in sealed envelope and should be clearly marked as "EOI Application for Short-listing for the Monitoring and indentifying comparative Benchmarking of fixed broadand internet in major cities of Lumbani, Jarnali and Sudurpakshim Pardesh (Package 3).The Envelope should also clearly indicate the name and address of the Applicant. Alternatively, applicants can submit their EOI application through e-GP system by using the forms and instructions provided by the system.
10. The completed EOI document must be submitted on or before the date and address mentioned in the "Request for Expression of Interest". In case the submission falls on public holiday the submission can be made on the next working day. Any EOI Document received after the closing time for submission of proposals shall not be considered for evaluation.

# **Terms of Reference**

## **For**

### **Consultancy Service to assess, measure and analyze QoS of fixed Broadband Internet Services (Package 3)**

#### **1. Background :**

Nepal Telecommunications Authority (NTA) is an autonomous telecommunications regulatory body established in February 1998 pursuant to Telecommunications Act, 1997 and Telecommunications Regulation, 1998. As per the provision of Sub-Section (f) of Section 13 of the Telecommunication Act, 1997, the Authority has to prescribe, fix and approve the standard and quality standard of the plant and equipment relating to the Telecommunications and the Telecommunications Service. And as per Section 14 of the same act, the Authority shall determine the quality and standard of the machine, equipment and facilities relating to the Telecommunications and the Telecommunications Service and prescribe the minimum standard to be maintained by a Licensee in operating the Telecommunications Service.

For further regulation of service quality of telecommunication services, the Authority has issued Bylaw Regarding Telecom Service Quality, 2017. As per this Bylaw Regarding Telecom Service Quality, NTA has prescribed different QoS KPIs for Internet Service.

NTA intends to recruit consultancy service to measure, assess and analyze fixed broadband internet service quality and conduct the consumer satisfaction survey regarding the QoS of fixed broadband internet service in different districts of Nepal and report to NTA. The projects intend to find out the quality of fixed broadband internet service provided by ISPs in different districts. Similarly, Consumer Satisfaction Survey will explore the QoS of Internet Service as consumer perception. It is expected to verify whether the compliance of the standard KPIs as prescribed by the Authority is met or not by the operators. In case of non-compliance, it is necessary to improve the quality of service as per the standard prescribed by the Authority. The consultancy service is divided into the following 3 different packages:

Package 1: Sites of Provinces 1 & Madhesh as prescribed in scope of work

Package 2: Sites of provinces Bagmati & Gandaki as prescribed in scope of work

Package 3: Sites of Provinces Lumbini, Karnali & Sudurpaschim as prescribed in scope of work

#### **2. Objective:**

The objective of the project is to

- To assess, measure and analyze the QoS of fixed broadband internet service provided by the different operators in different locations of Nepal.

- To conduct consumer survey and analyze the customers perception on quality of services of fixed broadband internet service in different locations of Nepal.

### 3. Scope of Work :

The scope of the work for consultancy is as mentioned below:

#### 3.1 Measurement of the Technical KPIs of Fixed Broadband Internet Service:

3.1.1 The consultant shall measure following Key Performance Indicators (KPIs) of Fixed Broadband internet services.

- i. Latency (Round Trip Time)
- ii. Packet Loss
- iii. Jitter
- iv. Throughput: Upload and Download
- v. Browsing Delay
- vi. DNS resolution time

3.1.2 The consultant shall perform national and international tests using the speedtest application available at NTA website (<https://speedtest.nta.gov.np/>) and other international standard tools for each site and present the collected speedtest data in the tabular format.

3.1.3 The consultant shall perform QoS Measurement from ethernet port of CPE device whenever possible, otherwise can measure via Wi-Fi but need to remark those sites. While performing the speed test, it should be ensured that no other live users are present in the network.

3.1.4 The consultant shall verify subscribed bandwidth of the consumer.

3.1.5 The consultant shall graphically present the QoS measurement values and KPIs district wise and ISP wise with their detail comparison.

#### 3.2 Consumer Satisfaction Survey regarding the QoS of Fixed Broadband Internet Service:

3.2.1 The consultant shall propose the *Consumer Satisfaction Survey Form* in a format to the NTA while submitting Inception Report to the Authority. The form shall include non-technical Key Performance Indicators (KPIs) of the QoS of Fixed Broadband Internet Service. A sample format of Consumer Satisfaction Survey is included in Annex-1.

3.2.2 The consultant shall collect the duly filled *Consumer Satisfaction Survey Form* from every measurement site, and henceforth analyze the forms and provide a report to NTA in suitable format.

### 3.3 Packaging Details:

The consulting firm shall assess measure and analyze QoS of fixed Broadband internet Services as mentioned in the following table in different packages as applicable:

**3.4** The QoS measurement sites at each District shall be selected based on the followings:

- i. Shall include Health **Post, Ward Office, Government High School, Hospital**, Private Organization and client premises.
  - ii. Shall include all incumbent operators (ISPs) service available in the District as far as possible.
  - iii. In case site has no access or closed or unable to measure due to some reason, perform measurement in another nearby site as applicable.
  - iv. If in case number of sample in any of the district is not available as mentioned in table 1 of 3.3 then total number of samples for particular province shall be managed from other mentioned districts of same province upon prior approval from the NTA.
- 3.5** The methodology and app used in the measurement shall be standard and genuine and the consulting firm should provide the details in the EOI/proposal as applicable.
- 3.6** The consulting firm shall submit separate EOI document for individual package. The shortlisting will be done for each package through the EOI process. In the second stage, the RFP would be issued to the shortlisted candidates and the evaluation of RFP will be done in the following order: Package 1, Package 2 and Package 3.
- 3.7** The consulting firm successful to win bid for any one package among 3 packages will not be qualified for other 2 packages. Thus if any one firm is selected in a package through RFP evaluation, the financial proposal of the firm in other remaining package/s will be returned without opening. Thus a consulting firm will be qualified to acquire consultancy service in maximum of 1 package only.

#### **4. Eligibility Requirement of the Firm**

The consulting firm should meet the following criteria:

- a. The consulting firm must be VAT registered.
- b. The consulting firm shall have Tax clearance of fiscal year **2078/79**.
- c. The consulting firm shall be of at least **5** years of standing. In case of JV the lead partner/firm shall have minimum 5 years of standing experience.
- d. The consulting firm shall have experience of minimum 2 Telecom/ICT projects

## 5. Duration

The assignment for different packages must be completed within time duration as mentioned in table below:

## 6. Team Composition

The Consultant shall have key professionals as mentioned hereunder:

- a. Team Leader: Should have a team leader with at least Master's Degree in Telecom/IT Engineering or equivalent and having experience of at least **7** years in Telecom Sector and also having experience of completion of at least **3** Projects in Telecom Sector as a Team Leader.
- b. Analyst: Should have an Analyst with at least Bachelor's Degree in Telecom/IT Engineering or equivalent with minimum of **5** years experience of working in Telecom/ICT Sector with minimum of **3** Telecom/ICT projects experience.
- c. Surveyor: Should have **eight nos. of** Surveyors in each package of 1 & 2 and **ten** nos. of Surveyors for package 3 with at least Bachelor's Degree in Telecom/IT Engineering or equivalent with minimum of 2 years experience.

## 7. Deliverables:

- 7.1 The consultant shall submit an inception report with an overall plan to conduct the QoS measurement and Consumer Satisfaction Survey within **15** days effective from the date of the contract.
- 7.2 The consultant shall submit a draft final report to NTA within **90** days effective from the date of the contract.

7.3 The consultant shall submit a final report and give a presentation to NTA officials after the completion of the work within **120** days effective from the date of the contract.
